Kay Bullock provided an overview of the Professional Standards Committee (PSC) including the legislation that led to the formation of the PSC, legislative requirements, and leadership.

3. **Accreditation Standards-Statewide and National Overview** (By Kay Bullock and Kristi VanAudenhove)

Kay Bullock provided an overview of how different states and professions have created and maintained their accreditation processes. Kristi VanAudenhove provided a history of the accreditation process for sexual and domestic violence programs in Virginia.

4. Accreditation Standards in Virginia- a Facilitated Discussion (Kristi VanAudenhove)

Kristi VanAudenhove led a discussion to develop the vision, purpose, and values of the PSC. The group identified the following ideas for the vision, purpose, and values:

Vision:

Consistent services across the state

Access for all survivors

Collaborative (relationship, processes within service area) -commitment to best possible services, legitimacy of program and services

Culturally relevant and gender specific services (accessible for all gender identities)

Communicative- no longer "the best kept secret"

Victim driven services- self-determination, victim rights, voluntary services

Individuality in agencies based on need and resources

Holding perpetrators accountable

<u>Purpose</u>: Members were asked to identify the purpose of the PSC and then to rank their importance (from strongly disagree to strongly agree)

- 1. Credentials/Legitimacy- Strongly Agree
- 2. Organizational development and growth- Somewhat to Strong

- 5. Reduce victimization, especially homicides- Somewhat Disagree to Somewhat agree/Strongly Agree
- 6. Improve strengthen communities (community response)- Middle to Somewhat Agree
- 7. Promote access to voluntary services for all- Middle to Strongly Agree
- 8. Self-evaluation/self-reflection- Middle to Strongly Agree
- 9. Linking standards to funding- Somewhat Disagree to Strongly Agree
- 10. Venue to ensure mission to "do no harm" Somewhat to Strongly Agree
