### Record (As-Built) Plans

The final plan milestone is Record (As-Built) Plans. These plans will show all adjustments and revisions to the Construction Plans made during construction and serve as a permanent record of the actual location of all constructed elements. As-Built Plans shall be prepared by a Professional Engineer licensed in Virginia and submitted with the final application for payment. Professional Engineer responsible for As-Built Plans shall certify to the best of their knowledge that the plans represent the actual locations of all constructed elements. As an example, the Professional Engineer should affix the following statement to the set of plans
